Cookie policy

This cookie policy is valid as of May 25, 2018.

About Cookie What is a cookie?

A cookie is a small file, generally made up of letters and numbers, which is downloaded to a computer's memory (or other equipment used for online browsing - mobile phone, tablet, etc.), when the user accesses a particular website.

Cookies are created when a user views a particular website in the browser (Internet Explorer, Chrome, Mozilla Firefox, Opera, etc.). The website sends information to the browser, and it creates a text file.

The purpose of cookies

Web application of selling online CFR Calatori and train timetable information use cookies for different purposes such as: improving the quality of the website for the user, storing user preferences and login information, or personalizing certain settings according to the needs of a particular user, such as:

- the language in which a site is viewed
- the currency in which certain prices or tariffs are expressed
- provides site owners feedback on how their sites are used by users so they can make them even more effective and accessible to users.

Essential and non-essential cookies

Essential cookies: These are Cookies strictly required for operating a website. Without these cookies, this site will not work properly. They allow you to navigate and use the features of our application.

Non-essential cookies: These do not fall under the definition of essential cookies because they are not strictly necessary for the operation of a site or its services, such as cookies used to analyze behavior on a website ("analytical cookies") or cookies used to serve ads.

Session cookies and persistent cookies

Session cookies - are session-specific, are stored in the user's computer memory only during an Internet browsing session and are automatically deleted when the browser is closed. They may become inaccessible even if the session has been inactive for a certain amount of time.

Persistent cookies - expire at a fixed point in time or if they are manually deleted from the web browser.

Legitimate interests: ensure the correct operation of online applications and services.

CFR Calatori uses non-essential cookies, analytical cookies that track and collect data about what a user is doing on the visited website. These cookies are not essential to the proper functioning of the site and the purposes for which they are used have been stated in the table above.

You can choose to block both essential and non-essential cookies. In this case, we inform you that it is possible that the web applications and their services may be affected partially or totally.
